This is to inform to all concerned that, PM SHRI K.V. No. 2 Binnaguri cantt. is going to start admission process for Balvatika 3 for the academic year 2024-25. There will be one section in Balvatika-3. The details of registration are as under:

1. Registration will start from: 01.04.2024 (Monday) from 10:00 AM onward
2. Last date of registration: 15.04.2024 (Monday) till 05:00 PM
3. Tentative Date of declaration of provisionally selected and waitlist of registered candidates: 20.04.2024 (Saturday)
4. Mode of registration: Offline

(Registration form will be provided by the school/can download from school website)

5. Age criteria:

Class	Age (as on 31 st march 2024) (Child born on 1 st April should also be considered).
Balvatika-3	Should have attained 5+ years but not completed 6 years of age.

6. Documents required to Registration for admission:

- (a) The Date of Birth (DOB) Certificate of the child issued by the competent authority. Original to be submitted at the time of admission for verification.
- (b) The certificate issued by competent authority for SC/ST/PH or DA/OBC (NCL) /EWS*/BPL* if applicable (for admission under RTE) in the name of the applicant along with original for verification.
- (c) Proof of residence (Voter ID/Bank Passbook/Gas Connection/recent Telephone or Electric Bill etc.)
- (d) An Undertaking by the parent stating the distance from residence to the school which is mandatory for admission in the RTE category. As per RTE act, the radial distance from the school to the residence should be less than or equal to 8 Kms.
- (e) For Central/State Govt. employees, a copy of the Service certificate of the parents issued by competent authority in the prescribed format.
- (f) In case of the Govt. employees the details of transfers during the last 7 years (01 Apr 2017 onwards) are duly signed by the competent authority in the prescribed form.
- (g) Self-attested copy of the Aadhaar Card of the Child.
- (h) Clinical proof of Blood Group with Rh factor.

7. The Admissions to the above class will be made as per KVS Admission guidelines 2024 25.
